- Train and raise awareness of all those employees who have influence in the manufacturing process of a product certified as HALAL.

- Elaboration of those foods certified as HALAL according to the standards established in the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Comply with the prescriptions established by the HALAL Certification Authority in their contractual documents and be subjected to a penalty system of the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Use raw materials for manufacturing HALAL products which have a Certification / Declaration / Technical Sheet or origin in accordance with the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Produce HALAL products which don't contain forbidden ingredients (Haram). Forbidden ingredients are listed in the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Elaborate HALAL products separately in time and space from the forbidden products (Haram).

- Keep the required documentation up to date in the Management System correctly, which is necessary for the compliance with the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Label the products that are classified as HALAL correctly, according to the Code of Use of the HALAL Guarantee Mark of the Islamic Council.

- Comply with the applicable legislation in force in the destination country where the products certified as HALAL will be supplied.

SORIA NATURAL S.A. Management Board shall take the necessary measures so that the HALAL Quality Policy be spread and executed in all areas of the organization, be kept up to date, and be useful as a management tool at all times.
